PRIVACY IN GENERAL

THE CHIC ITALIAN does not collect and process personal data unless you have provided it to us. THE CHIC ITALIAN may process personal data about you by using the services of THE CHIC ITALIAN, and / or by providing it yourself when filling out a contact form on the THE CHIC ITALIAN website.

FIRST

THE CHIC ITALIAN does nothing with your data and will not sell it to third parties. We treat the obtained data confidentially. The processing of the data takes place in accordance with the requirements of the General Data Protection Regulation (GDPR).

However, a number of services and plug-ins from third parties are used for the operation of the website. Below is information about the services THE CHIC ITALIAN uses and what they possibly do with the acquired information.

THE CHIC ITALIAN

THE CHIC ITALIAN is a blog for everything style, career, travel and lifestyle related. It is not registered as a company at the moment. However, THE CHIC ITALIAN is responsible for the personal data that you share with us. When the terms 'us', 'we', 'l' or 'THE CHIC ITALIAN' are mentioned it refers to the blog THE CHIC ITALIAN.

COLLECTED DATA

Collected data

THE CHIC ITALIAN uses Google Analytics (see below) to see visitors behavior. We do not receive any IP addresses or other personal data. If you contact us, we will save the name you entered and the email address you used.

THE CHIC ITALIAN also collects data in the form of comments and emails send through the contact form.

Goal

The collected data is only used to create new content and when responding to emails and comments left on the blog. Personal data are not made public or provided to third parties, except when they are stored on servers, for which we purchase services from third parties.

Term

THE CHIC ITALIAN does not store your personal data for longer than is strictly necessary to achieve the goals for which your data is collected. Your data will not be stored for longer than 1 year. This is not in violation of the law.

Sharing with third parties

UW RECHTEN

We want to point out that you have certain rights under the General Data Protection Regulation law (GDPR):

Right to information

What does this mean? You have the right to receive clear, transparent and understandable information about how we use your personal data and about your rights. This privacy statement has been drawn up to inform you about your rights and what personal information we collect from you.

Right to inspection

What does this mean? You have the right to view your own personal data. You can request access to this via the contact details below. You do not have the right to request personal data from another person. There are certain conditions under which we can refuse this inspection. It is possible that we ask for proof of identity before we carry out your request. You may also be charged for administrative actions.

Right to correction

What does this mean? You have the right to have your personal data corrected if they are factually incorrect or irrelevant for the purpose for which they were collected, outdated and / or to have them supplemented if they are incomplete. You can submit a request via the contact details below.

Right to be forgotten

What does this mean? You have the right to request to get all your data be deleted. This is possible because something no longer requires the data, you have previously (explicitly) given permission to use something for the use of your data, but now withdraw this permission in or for the following reasons: objection, unlawful processing, legally stipulated retention period or if you are younger than 16 years old.

Right to objection to personal data processing

Right to transfer data
